### SRRC Board of Directors Meeting 03/12/19

#### I. Call to Order/Roll Call

The meeting commenced at 5:35p.m.

The following directors were present, constituting a quorum:

### **II.** Officer Reports

### A. <u>Secretary's Report</u>:

Kristina circulated in advance of the meeting the minutes from the last meeting. Matt moved to approve, John seconded the motion. Approved by unanimous vote.

### B. <u>Treasurer's Report</u>:

Kathleen circulated in advance of the meeting a report for \$96,745.17 showing the balances as follows: Lincoln Presidential Half Marathon \$57,277.48, SRRC Operating \$2,855.00, and SRRC Sweep \$36,612.69.

Rick moved to approve, Emily seconded the motion. Approved by unanimous vote.

Kathleen advised that that the funds received for the HalfWits buffs exceeded the costs. Tammy explained that the price was calculated to cover the cost of the buff plus the credit card fee for the purchase. SRRC received a volume discount on the order and those ordering multiple buffs only paid one credit card fee, resulting in a surplus.

Kathleen proposed applying the surplus to cost of the HalfWits breakfast.

Nick moved to approve the proposal. Tammy seconded the motion. Approved by unanimous vote.

Kathleen asked that race directors be advised to notify Kathleen of any deposits so that she could properly account for them in a timely manner.

Carrie proposed an annual budget for SRRC. The board agreed to further discuss an annual budget.

Kathleen reported that the annual report is late. Kathleen proposed a change of registered agent to a current board member. Carrie agreed to act as registered agent. Kathleen will prepare the annual report with change of agent.

Kathleen asked whether SRRC will use Sikich to prepare its Form 990 this year. Kathleen will inquire about the fee at other accounting firms.

# C. Membership Report:

Matt reported 412 members as follows: 169 adult, 211 family, 11 student/youth, 21 Hall of Fame. Total membership is up 53 members than last year at the same time.

### D. **Special Programs Report**:

Randi reported that she booked a bus with Vandalia for the St. Louis brewery social in October. SRRC will charge members \$35 to cover the cost of the bus.

Randi proposed a social called "Sunday Funday" on May 19, 2019. Members will gather at Rolling Meadows Brewery and be bussed to 2 points on the Sangamon Valley Trail (5mi and 3mi out), and then run back to the brewery for a social. Randi proposed a budget of \$300.00 (consisting of \$115 to rent Rolling Meadows Brewery for 2 hours, \$75 for the bus, and \$100 for snacks). Members will purchase their own beer. The social will be limited to 40 people (the max at Rolling Meadows Brewery). Members will be required to register in advance for the social and pay a nominal \$5.00 fee. Matt moved to approve the \$300.00 budget. Kristina seconded the motion. Approved by unanimous vote.

Carrie will follow up with Tommy and Lori Dale regarding planning the HalfWits breakfast.

### **III. Race Director Reports**

#### A. Lincoln Presidential Half:

Carrie reported 1350 participants are registered. Nick advised that registration will be capped at 1500 because only 1500 medals were ordered. GMR registration is capped at 1500. Rick is working on finding water stop volunteers. Tammy reported GMR registration is open for volunteers. Nick advised that Dave Drennan will step down as race director after 2021.

#### B. Women's Distance:

Tammy reported that registration opened on March 1.

#### C. Parade Run:

Carrie reported that the race directors are working on setting up registration. The race route is still unknown and depends on the parade route.

### D. Abe's Amble:

Carrie reported that registration will open after registration for Abe's Army closes, around Memorial Day weekend. Carrie has been in contact with the Park District and Oak Ridge Cemetery regarding the race route. Carrie will submit the event form to the Park District.
